### **Updated: April 12, 2018**

Judge Timothy McCarthy sentenced DeAnthony Wiley to life in prison, without possibility of parole for 25 years. Wiley was considered the ring-leader of the 4 defendants and was the defendant who killed Jon Bieker at She's A Pistol gun store in Shawnee, KS on January 9, 2015. Wiley previously pled guilty to first degree murder, attempted aggravated robbery, conspiracy to commit aggravated robbery and aggravated battery.

### March 29, 2018

Judge Timothy McCarthy sentenced Nicquan Midgyett to life in prison, without possibility of parole for 25 years, plus an additional 48 months, for his role in the homicide of Jon Bieker at She's A Pistol gun store in Shawnee, KS on January 9, 2015. Midgyett previously pled guilty to first degree murder, attempted aggravated robbery, conspiracy to commit aggravated robbery and aggravated battery.

### February 27, 2018

Today, DeAnthony Wiley pled guilty to first degree murder, attempted aggravated robbery, conspiracy to commit aggravated robbery and aggravated battery. Wiley is the final defendant in the homicide of Jon Bieker at the "She's A Pistol" gun store in Shawnee, KS to be convicted. Sentencing is set for April 12, 2018. The cases were prosecuted by Assistant District Attorneys Vanessa Riebli and Jacob Gontesky. The Shawnee Police Department, the Johnson County Sheriff's Office Criminalistics Laboratory, the Kansas City Missouri Police Department, and the Bureau of Alcohol, Tobacco, and Firearms were the investigating agencies.

### December 13, 2017

Today, on day 3 of his jury trial, Nicquan Ke-Aaron Midgyett, pleaded guilty as charged to include counts of first degree murder, attempted aggravated robbery, and conspiracy to commit aggravated robbery. Midgyett had previously pleaded guilty to aggravated battery in this case. Midgyett will be sentenced on March 8, 2018.

### August 25, 2017

Judge Timothy McCarthy has sentenced Hakeem Malik, Jr. to life in prison, without the possibility of parole for 25 years, for his role in the homicide of Jon Bieker at She's a Pistol in Shawnee, Kansas on January 9, 2015.

May 25, 2017

Hakeem Malik, Jr. has pleaded guilty to first degree murder, attempted aggravated robbery, conspiracy to commit aggravated robbery, and aggravated battery in the complaint filed in his case, 15CR77. Sentencing is scheduled for August 25, 2017 at 1:30 p.m.

May 18, 2017

A jury has found Londo Emanuel Patterson, III guilty of first degree murder, attempted aggravated robbery, conspiracy to commit aggravated robbery, and aggravated battery in this case

January 12, 2015

The Johnson County Kansas District Attorney's Office announces on January 11, 2015, four individuals were charged with felony murder in the January 9, 2015, death of Jon Bieker at "She's a Pistol", a business in Shawnee, Kansas.
